

## Waiver of Liability

By registering for or attending an event under the control of or located on premises owned, occupied or controlled by B. Weaver Apiaries, Inc., BeeWeaver Honey Farm, BeeGoods Mercantile, WildFlyer Mead Co., Bee Power, LLC or Bee Weaver Apiaries (the Releasee companies) you are acknowledging that the companies are agritourism entities. You agree, on behalf of yourself and any and all children for whom you are parent or guardian, and others who travel with you, that you and others for whom you are responsible will be participating in agritourism activities on agricultural land for educational and recreational purposes, and under Texas Law, an agritourism entity or agricultural or recreational enterprise is not liable for injuries or death resulting from an agritourism or agricultural and recreational activity.

You also agree, both for yourself and any minor person for whom you are parent or guardian or supervisor, that Texas Law will apply to any actual or alleged occurrence, incident, act or omission that may transpire or is alleged to transpire during your visit, attendance or time on the Releasee companies' premises, property, as well as any property in their possession or under their control, and that Texas will apply to any right, claim, demand, cause of action, suit or judgement you or any minor for whom you are parent or guardian or supervisor may have, assert or attempt to enforce.

You also agree that you understand and are aware that honeybees and other hazards inherent to agricultural, apicultural and farming and ranching operations will be present and these hazards pose the risk of property damage, bodily injury, and death.

You agree that you and others attending with you accept these risks voluntarily and you, acting for yourself and any children for whom you are parent or guardian or supervisor, release the entities named above, and their owners, managers, members, officers, directors, employees, agents and contractors, from all liability for any damage, injury or death that may result.

By signing this form or registering for or attending an event or activity you also agree to waive any and all claims, demands, causes of action and completely release B. Weaver Apiaries, Inc., Bee Weaver Honey Farm, Bee Goods Mercantile, WildFlyer Mead Co., Bee Power, LLC. and Bee Weaver Apiaries (collectively referred to as the Releasee companies), their officers, directors, managers, members, owners, employees, agents and contractors from any claim, demand, cause of action, suit or judgement you may have for any damages sustained from the activities or events you attend and any hazards or risks that the agricultural, apicultural, or farming and ranching operations present. Releasor agrees to release the Releasee companies from and against any and all claims or damages including, but not limited to, claims for bodily injury and/or property damage and/or wrongful death, whether such claims or damages are caused, or allegedly caused, in whole or in part by the negligence or other conduct, including gross negligence of the Releasee companies if and to the fullest extent allowed by Texas Law, as well as any alleged negligence or gross negligence or other actions or omissions of any of the officers, directors, managers, members, owners, employees, agents and contractors of the Releasee companies.
